(Note about the number of OTC FX active accounts in FX Trading (OTC FX))

Monex, Inc. provides several services of FX Trading (OTC FX) and the number of FX active accounts excludes duplicate active accounts at Monex, Inc. from the gross total number of OTC FX active accounts.

(Note about DARTs of Monex, Inc.)

DARTs of Monex, Inc. comprise trades of stock brokerage, futures and options, OTC FX, OSE-FX, mutual funds, TFX-CFD and bullion (gold, silver & platinum).
