

Monex to Broaden Market Information Service with Beta Launch of “MONEX INSIGHT”

- New Service Employs Enhanced Visualizations of Market Data and Intuitive Operability

TOKYO, April 3, 2013 – Monex, Inc., a fully owned subsidiary of Monex Group, Inc., today announced that it will improve upon its market information service with the launch of “MONEX INSIGHT” in late April 2013. Prior to the official release, Monex, Inc. clients will have access to a beta version of this new service starting on April 4, 2013. (*1) (*2)

MONEX INSIGHT will be jointly developed by Monex, Inc. and its U.S. group companies, TradeStation Securities, Inc. and TradeStation Technologies, Inc. (collectively, “TradeStation”) for Monex, Inc.’s clients in Japan.

- (*1) The April 4, 2013 launch of the beta version of MONEX INSIGHT will include limited operational resources and support and is intended to give clients a chance to experience this new service prior to its official release.
- (*2) Monex Inc.’s clients will be able to continue using Monex, Inc.’s current market information service for about a month after the official launch of MONEX INSIGHT, scheduled for late April 2013.

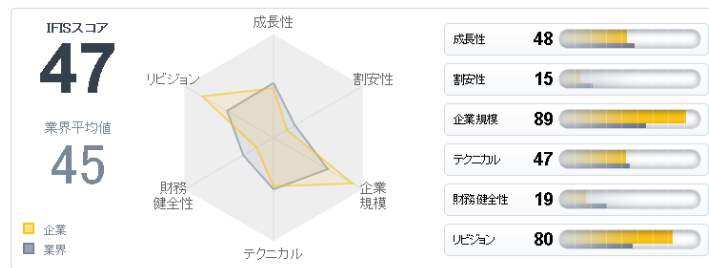
