Announcement of Management Changes

TOKYO, March 7, 2016 - Monex Group, Inc. (the "Company") hereby announces changes to its management team effective April 1, 2016.

Since 2011, the Company, together with its group subsidiaries, has been dedicated to developing certain "Global Vision" mid- to long-term strategies. As realization of that goal approaches, the Company has decided to take steps toward further increasing its corporate value with a team that will strengthen its global business management.

In addition, the Company announced today candidates for its board of directors to be submitted for approval at its annual general meeting of shareholders to be held in June 2016. The candidates were nominated by the Nominating Committee of the Company with the view of enhancing corporate governance. One new board member is being proposed, and seven (7) out of the eleven (11) nominees are to be independent and outside directors.

The Company also plans to offer an allotment of stock acquisition rights (stock options with paid premiums) to executives and employees of the Company and its subsidiaries which are exercisable only if certain operating income levels are met over a mid- to long-term period. The purpose of these stock acquisition rights is to be consistent with the Company's transition of its global business plan from an investment phase to a profit-expansion phase, aligning the incentives of the management team with that profit growth. Dilution of the Company's issued and outstanding stock resulting from the issuance of these stock acquisition rights will not exceed 4.10 percent.
